

# PUBLICATION AGREEMENT

Supplementary series "Tyche. Beiträge zur Alten Geschichte, Papyrologie und Epigraphik", edited by the "Verein zur Förderung der Alten Geschichte in Österreich".

Title of the contribution:

The author agrees to the Tyche Association publishing and distributing the contribution named above in a volume of the Tyche supplementary series, in printed and electronic form i.e. as an electronic attachment, and also agrees to the Tyche Association making the contribution named above available for access on electronic platforms (as an open-access article) and digital reading devices (Kindle, iPad, etc.), for online usage (chargeable and non-chargeable). The author cedes the contribution to the Association. The author and the Association are in agreement regarding the following points:

## Declarations made by the author:

The author's work has not gone to print elsewhere previously, either in part or as a whole. The author is aware that the work will be distributed in printed form by means of a publishing house. He/she will therefore not utilise the work in any other way once it has been accepted for printing unless he/she has the advance approval of the Association.

The Association is obliged to provide the author with legible extracts/plots that are entirely easily readable, which the author will immediately correct and add a note stating "ready for printing"; the addition of this note also approves any deviations from the manuscript.

If the author makes changes in the finished typesetting, any additional costs arising from this will be billed to him at the publishing house's cost price if these costs exceed 5% of the typesetting costs for the work.

In order to guarantee a smooth production process and that the journal is issued promptly, the author will adhere to the deadlines set for him/her by the editorial department.

The manuscript, ready for copy and typesetting, will be delivered to the Association by the author on an EDP data carrier (CD, DVD, or USB stick) or by email or via FTP, in the form of MS Word **and** print-ready PDF documents. Graphical material such as photos, tables, sketches and scans must be ready for print (minimum requirements 300 dpi, as JPG, BMP, PNG, EPS or PDF) and be transferred separately from the manuscript. The work is considered accepted when it has been assessed positively by both an internal and external review (double-blind peer review).

Additionally to the manuscript, the author also transfers the following accompanying documents to the Association, which are used for Meta data, categorisation, labelling and other best-possible distribution of the article:

- An abstract/summary of the article.
  - Length: approximately 500 characters including spaces.
  - Language: English and the language in which the article is written
- Keywords: At least 5 keywords, exclusively in English.

## Editing and layout

The Association bears the responsibility for editing the contribution. Editing concerns all decisions regarding the composition and design of the contribution in the Tyche supplementary volume, and the Association reserves the right to make decisions about image scales and layout suggestions.

### Granting usage rights

The author grants the Association the rights - unrestricted as regards locality, time and content - to the utilisation of the work for the usage types detailed in the following. The Association may grant the rights ceded to it to third parties, as non-exclusive or exclusive usage rights. The author agrees to these rights being passed on. Should it be possible for a collecting society to administer any of these rights, the author authorises the Association to conclude the appropriate contracts.

The author transfers the exclusive right to use the work for all usage types reserved to the author in accordance with the Austrian Copyright Law for all editions and circulations of his/her work.

#### Ancillary rights

In order to guarantee the best possible distribution of the work in all suitable usage types and their coordination, the author transfers the following ancillary rights to the Association:

- The right to prepublication and reprinting, in whole or in part, in newspapers, magazines, anthologies and other collections;
- The right to allocate licences for editions in other countries, as well as for special, reprint, school, micro and book club editions;
- The right to archive the work in databases, as well as to publish, distribute and make the work available in digitalised form (e.g. via online services, websites, print on demand services, digital reading devices such as the Kindle or iPad, open-access journals, Podcasts and storage media such as CDs, DVDs, USB sticks and other data carriers), or to arrange for it to be published, distributed and made available; this right in particular also applies for technical forms of publication, distribution and the work being made available, which are currently not viable but will only be possible in future.
- The right to public recital as well as to the commercial or non-commercial loaning of the work;
- The right to translating the work into other languages and to utilising these language versions in accordance with all of the contractual usage types.

The Association is entitled to edit the work for the utilisation of such rights itself and to arrange for this to be done by third parties (including decreasing and increasing its length) as well as to arrange for such rights to be exploited by issuing licenses to suitable companies. Editing is always performed following consultation with the author.

The Association receives the rights named above as exclusive rights. Simultaneously to publication – and in particular in the event of open access publications – the Association will grant a non-exclusive usage right to each author on request. This usage rights enables the author to exploit his work himself (e.g. on his own homepage, or on university servers) or to arrange for third parties to exploit it (including through publishing houses). The author must however ensure in the event of such usages that the first publication in the Tyche supplementary volume is named as a source (see regulations on dealing with offprints below). This also serves for improving the citability of these first sources, which are particularly important for scholarship. For any possible links to the contribution on websites and servers, the author is encouraged to use the new open-access website of the Tyche Journal for the purposes of improving citability.

## Guarantee

The author affirms that he/she is the sole owner of all rights to the present work and that third-party rights are not infringed by the intended usage. This in particular includes the master illustrations, plans, maps, sketches and tables contained in the work named above. The author has collected the third-party usage rights or approvals required for their usage.

In this respect, the author releases the Association from all third-party claims, including the costs of legal defence. This also includes rights for online usage/publication.

## Fee, PDF documents

The author will not receive any separate fee for the publication of the contribution. He/she receives a PDF document as a digital reproduction of his/her printed contribution. The contribution may be published on the Tyche website as a PDF, HTML, XML and/or full text file. The Association holds the ownership and usage rights to this PDF. The author has the right to create copies of this PDF for his/her own scientific use. The original version of the document, including all information on the copyright and place of publication, must be retained.

#### Open-access publication of the contribution in other repositories

The Association allows the author to publish a version of the text that differs from the print version (and the offprint PDF named above) in terms of its typography, pagination and layout, 24 months after the publication of the contribution in a repository that is publicly accessible free of charge, on the condition that this includes a clear reference to the original publication source.
